David J. Ko, being duly sworn, deposes and says:





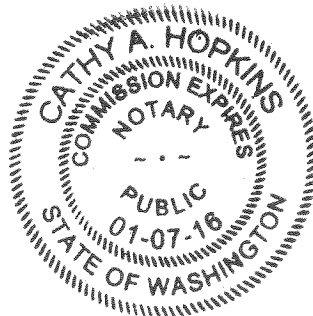
