**AFFIRMATION OF MICHAEL A.

MICHAEL A. ROLLIN, an attorney duly licensed to practice law in the State of New York, affirms under penalty of perjury and says:

1. I am a member of Jones & Keller, PC, attorneys of record for intervenor the W&L Investments, LLC ("W&L Investments") in the above captioned action.

2. I am familiar with the proceedings in this case and make this affirmation in support of the motion to admit Maritza Dominguez Braswell, shareholder in Jones & Keller, PC, as counsel *pro hac vice* to represent W&L Investments.
