
JARED M. SLADE, being duly sworn, deposes and states as follows:



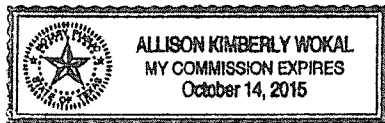
