
**STIPULATED ORDER EXTENDING PRODUCTION**  
**DEADLINE SET ON OCTOBER 17, 2013**

Plaintiff, Federal Home Loan Bank of Pittsburgh ("FHLB") and Defendants JPMorgan Chase & Co. ("JPMC") and J.P. Morgan Securities LLC, formerly known as J.P. Morgan Securities Inc., (the "JPMorgan Defendants"), by and through their undersigned attorneys, hereby stipulate that the deadline set by Order of October 17, 2013 for the production by the JPMorgan Defendants of a draft DOJ Complaint is hereby extended. The JPMorgan Defendants shall have until November 15, 2013 to either produce the draft DOJ Complaint or seek relief from the Court as to that portion of the October 17, 2013 Order requiring its production. FHLB has agreed it will not argue that the JPMorgan Defendants should have brought any motion for relief from the October 17, 2013 Order earlier than November 15, 2013.


