**AFFIRMATION OF JARMAN D. RUSSELL  
IN SUPPORT OF THE TRUSTEES' FIRST AMENDED PETITION**

I, JARMAN D. RUSSELL, an attorney admitted to practice in the courts of the State of New York, pursuant to CPLR § 2106(a) and under the penalties of perjury, affirm that:

1. I am an associate of the firm Mayer Brown LLP, attorneys for petitioners The Bank of New York Mellon (“BNYM”) and The Bank of New York Mellon Trust Company, N.A., (“BNYMTC”) acting solely in their capacity as trustee for certain residential mortgage-backed securitization (“RMBS”) trusts. I submit this affirmation in support of the Trustees’ First Amended Petition.
2. At issue in this case are 43 trusts for which BNYM serves as trustee and 15 trusts for which BNYMTC serves as trustee (the “Trusts”). These Trusts are listed in Appendix A to this affirmation.
3. The majority of the Trusts are governed, at least in part, by a Pooling and Servicing Agreement (“PSA”). Two of the Trusts are governed by, among other agreements, an Indenture and a Sale and Servicing Agreement (“SSA”). The PSAs and Indentures that govern the Trusts are included in Trustees’ Exhibit 014.
4. Each PSA includes a provision that the Depositor assigns to the Trust or the Trustee, for the benefit of Certificateholders, all of its “right, title and interest” in and to the Mortgage Loans. *See, e.g.*, BALTA 2005-1 PSA § 2.01.
5. For the two Indenture trusts, the Depositor first assigned to the Issuer all of its “right, title and interest” in and to the Mortgage Loans in the SSA. *See, e.g.*, BSARM 2005-7 SSA § 2.01. The Indenture for each trust then states that the Issuer grants to the Indenture Trustee “all of the Issuer’s right, title and interest” in and to the Mortgage Loans. *See, e.g.*, BSARM 2005-7 Indenture.
