On March 14, 2018, this court so-ordered an unopposed Partial Severance Order and Partial Final Judgment (the Partial Judgment) (NYSCEF No. 267) applicable to 92 Trusts in this special proceeding. On March 15, 2018, counsel for the Institutional Investors filed a letter, informing the court that "[a] potential issue with another purported certificateholder has arisen with respect to one of the 92 Undisputed Trusts—SAMI 2007-AR7—included in that Proposed Order [the Partial Judgment]." Together with the letter, the Institutional Investors also filed an amended version of the Partial Judgment which removes SAMI 2007-AR7 from the list of Trusts to which the judgment applies.

It is accordingly hereby ORDERED that the Partial Severance Order and Partial Final Judgment, so-ordered on March 14, 2018, is hereby VACATED without opposition. Absent any opposition, an amended partial severance order and partial final judgment will follow.
