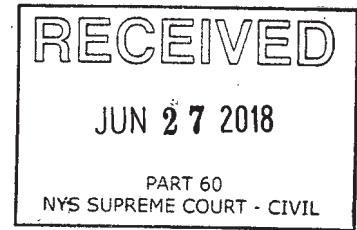

WHEREAS, Axonic Capital LLC (“Axonic”) filed a motion seeking an order permitting Axonic (i) to file under seal exhibits A, C, D, G, H, and I annexed to the Affirmation of Neil S. Binder; and (ii) to file under seal unredacted versions of (a) Axonic’s Memorandum of Law in Opposition to the Challenging Respondents’ Joint Motion to Limit Standing to Certificateholders in the Settlement Trusts and (b) the Affidavit of Jamshed Engineer, dated April 11, 2018 (“Axonic’s Sealing Motion”) (Mot. Seq. No. 008, NYSCEF Doc. Nos. 343-45);

WHEREAS, Nover Ventures LLC (“Nover”) filed a motion seeking an order permitting Nover to file under seal: (i) an unredacted version of the Memorandum of Law in Opposition to Consolidated Memorandum of Law in Support of Joint Motion to Limit Standing to Certificateholders in the Settlement Trust; and (ii) an unredacted version of the affirmation of

David I. Schiefelbein, together with exhibits (“Nover’s Sealing Motion”) (Mot. Seq. No. 009, NYSCEF Doc. Nos. 346-48);

WHEREAS, a hearing was held before the Court on May 7, 2018 (the “Hearing”);

WHEREAS, after consideration of Axonic’s Sealing Motion, and Nover’s Sealing Motion (together the “Sealing Motions”), and the statements of counsel at the Hearing, good cause exists to grant the Sealing Motions to protect confidential information;

ACCORDINGLY, it is hereby:

ORDERED that the Sealing Motions are granted; and it is further

ORDERED that Axonic may file under seal: (i) Exhibits A, C, D, G, H, and I annexed to the Affirmation of Neil S. Binder (NYSCEF Doc. Nos. 332, 334, 335, 338, 339 and 340); (ii) an unredacted copy of Axonic’s Memorandum of Law in Opposition to the Challenging Respondents’ Joint Motion to Limit Standing to Certificateholders in the Settlement Trusts (NYSCEF Doc. No. 433); and (iii) an unredacted copy of the Affidavit of Jamshed Engineer, dated April 11, 2018 (NYSCEF Doc. No. 434)¹; and it is further

ORDERED that Nover may file under seal (i) an unredacted version of the Memorandum of Law in Opposition to Consolidated Memorandum of Law in Support of Joint Motion to Limit Standing to Certificateholders in the Settlement Trust (NYSECF Doc. No. 435); and (ii) an unredacted version of the affirmation of David I. Schiefelbein, together with exhibits (NYSECF Doc. No. 436)²; and it is further


