BEAUREGARD A. FOURNET, having been so sworn, testifies as follows:

1. I am an authorized signatory for HBK Master Fund L.P. (“HBK”), an interested party in this Article 77 proceeding. I submit this affidavit in accordance with the Court’s Clarifying Order, dated January 22, 2018, to provide evidence of HBK’s interest in certain Settlement Trusts. Unless otherwise specified, the factual matters set forth herein are based upon my personal knowledge or a review of HBK’s files.

2. HBK in an investor in 20 NIMS trusts that own 59 bonds issued by 21 RMBS trusts that are among the Settlement Trust to which the Petition relates.


